An overnight and accelerated Top-Up Offering whereby Pan Malayan Management and Investment Corporation ("PMMIC"), the principal shareholder in the Bank, shall offer and sell up to US\$100 million worth of its common shares in the Bank (the "Offer Shares"): (i) primarily offshore by way of marketed placing to third party institutional investors outside the United States in reliance on Regulation S under the U.S. Securities Act of 1933, as amended (the "Securities Act") and within the United States to qualified institutional buyers, as defined in, and in reliance on, Rule 144A under the limited а Securities Act; and (ii) to domestically to (1) qualified buyers pursuant to Section 10.1(1) of the Securities Regulation Code ("SRC"); and (2) not more 19 non-qualified buyers pursuant to Section 10.1(k) of the SRC (the "Placement Tranche"), under such terms and conditions as provided in the agreement to be

executed. The pricing of the Offer Shares will be determined following the completion of an overnight and book-building exercise by the placing agents to be appointed, provided that the minimum placing price per share shall be Php60.00

As part of the same transaction, PMMIC shall subscribe to, and the Bank shall issue, the exact same number of common shares as the Offer Shares that PMMIC sold in the Placement Tranche (and at the same price), which shall be issued by the Bank from its authorized but unissued capital stock (the "Subscription Tranche"), under such terms and conditions as provided in the agreement to be executed.

(b) In relation to such Top-Up Offering, the appointment of Credit Suisse, Deutsche Bank, Macquarie, and Maybank ATR Kim Eng as the Joint Bookrunners for the Top-Up Offering as well as the Placing Agents to be nominated.
